The Treasurer's Report: Current Account balance is \$21,431.95.

Committee Updates:

- a. Security/Safety: No Update. No representatives from the 24th District present.
- b. Security Cameras: The City Commerce Department continues to wait for the Pa. Dept. of Community & Economic Development (DCED) in Harrisburg to release the funds for the various Philadelphia neighborhood projects. These dollars include the \$30,000 in RCA-PRIDE joint funds approved to upgrade the Security Camera system. \$10,000 of that total is earmarked for RCA.
- c. Membership: There are currently 28 paid members. Membership outreach and recruitment continues to be conducted by Steve Horton. The Committee will need to plan for the Membership Reception/Event with Public Officials in August to be held at the Columbia Club located at Tioga & Almond Streets.
- d. Strategic Plan: No Update
- e. Media/Public Relations: No Update
- f. Website: Steve Andrews, our Website Designer, made a few editorial revisions. and submitted his regular invoice for services.
- g. Clean Up: We had a very poor turnout by RCA businesses for the Citywide Clean Up on Saturday April 13th. We really thank those businesses who did step up to help out. The general feeling among those who did participate the day of the event, is that we may not continue this Semi-Annual Project unless more companies get involved. RCA has been working on neighborhood cleaning and community improvement projects since 1998.

New Business:

The representatives form Gannett-Fleming and PENNDOT gave a power point presentation and displayed Maps regarding the Reconstruction of I-95. Currently, an engineering study of the section in the RCA area, stretching from Ann Street- Frankford Creek, is underway. In addition, an environmental clearance plan is being developed. It appears it will be approximately 3-4 years before actual contract work on the Interstate Highway begins.
