- 1. Minutes from the September general meeting were self-read and approved.
- 2. Bruce Richman, Treasurer, announced that RCA's fund is \$19397.11.
 Bruce stated that Washington Savings Bank did not pay but Steve Horton stated that they did an internal transfer.
- 3. Steve Horton distributed a sheet with a list of local companies in the RCA zone that he reached out to with the hopes of members knowing a name within one of these companies. If so Steve asked for the RCA member to set up an introduction with that prospective new member.

- 11. Linda Lawrence form the City of Philadelphia Commerce Department spoke about the Safety Cam program for businesses. There is up \$3000 in grant money to be awarded per businesses which qualify.
