Safety/Security: No Updates. 24th Police District representatives did not attend. RCA is located within Police Service Area (PSA) #3. Rolando Sanchez announced the Aramingo BID has expanded its security & safety services.

Maxine Ferguson made a presentation about the newly targeted Business Security Camera Program (SafeCam) which covers 100% of the costs (up to \$3000) for businesses who install exterior cameras on their buildings. RCA is located within the target area. This new expansion of the Program is the result of the Mayor's Executive Order under the City Resilience Project.
