RCA appreciates the partnership with City Agencies. The organization supports legislation that will significantly increase penalties for violators. In

addition, RCA requests that City Video Surveillance Cameras be installed in the areas hardest hit.Everyone will need to continue being the "Eyes & Ears" by contacting "311" and/or "911" when incidents occur. The Energetek representatives made note of a Galveston, Texas model that utilizes a GIS system that helps in the tracking and enforcement of these types of situations. We will follow up with them to get more specific information & share with local Officials.

Business Updates & Announcements:

PhilaPort has installed new Shipping Cargo Cranes at Packer Terminal. The dredging of the Delaware River, 101 miles of shipping lanes to a depth of 45 ft., is almost complete. St. George's School is operating as an independent educational Institution. The School is celebrating its Centennial (1920-2020) next year. The current enrollment is 146, with a goal of 160 students in the future. The ongoing fundraising efforts for the School will kick off with a Carnival in September.

Pulaski Park improvements have finally been completed. A ribbon cutting ceremony was held on April 30th. This is part of the vision for the "Richmond Immigrant Village" included in the City Planning Commission's River Wards Plan.

KICA, Harrowgate Civic Assoc. and other neighborhood partners continue to be very active in monitoring & voicing opposition to the proposed self-injection sites in the area. With the ongoing Opioid crisis, numerous meetings & conversations are taking place with Public Officials inorder to create fair & reasonable policies, programs and solutions.
