Security & Safety: The Police District continually reviews & adjusts the deployment of Officers throughout Neighborhoods. During the civil unrest of October 27th & 28th, the Aramingo Ave. commercial district was hit very hard by Looters. There were 65 Commercial Building Burglaries and an estimated \$5.5 Million in damages & losses. In addition, there has been a major uptick in Street Violence. This year, the 24th PD has experienced 50 Homicides and 231 Shooting Victims. Building Partnerships continue to be a top priority as We address these big challenges together. Those in attendance all agreed to strengthen our ongoing collaboration. One major priority is the need to grow & expand Workforce Training & Placement opportunities throughout the Region.
